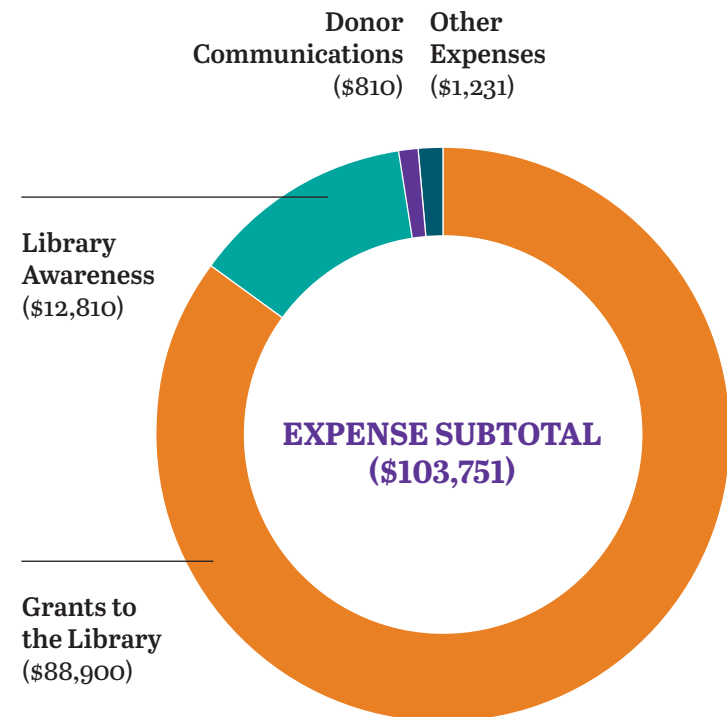
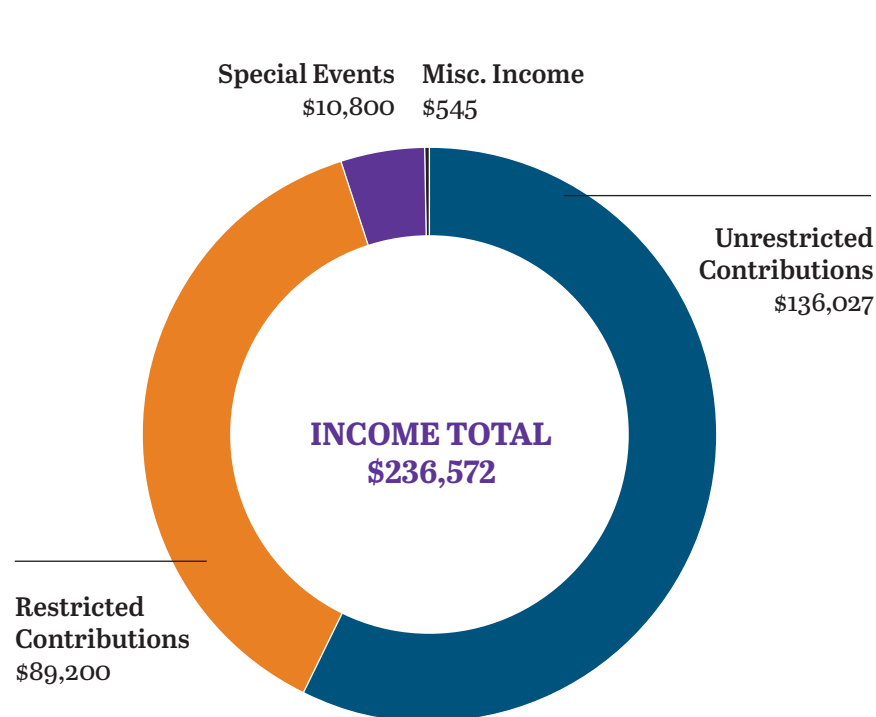
The mission of the Hudson Area Library Foundation is to develop and implement ways that provide support for the growth and enhancement of the Hudson Area Public Library.
